the purpose of legal research is to explain a legal rule or to interpret the meaning of a text to determine its validity. the purpose is to find out whether it is valid or not. the methodology is to examine a law along with its impact on society and to determine the validity of the law. in this way, it also makes a study of the law from an economic, social, and political perspective. the sources which are useful for a legal research are of three kinds, which are primary, secondary, and tertiary. primary sources are those which are of the first kind, which are the basis for the data and facts in legal research. secondary sources are those which are not of the first kind, but are the original sources of primary sources. these are a type of secondary source and are the basis for a legal theory which is a type of the third kind of source. the third kind is tertiary sources which are the types of a secondary source which are a subject of study, which are not the basis for the legal theory but are necessary to determine its validity. this type of data is also called empirical and primary sources have been enumerated in a secondary source collection in a library. the primary source collection is the source of all other sources and the basis for legal research. there are various methods to do legal research. the most common of them is the legal rule which is based on legal logic. legal logic is the process of determining whether a law is valid or invalid. it is the process of determining the validity of the law or its application by the legal system. this method is based on the doctrine, which is a jurisprudence of law in which the validity of a legal principle is determined. 5ec8ef588b
