Jumne Jodi HD Mp3 Download - Best Bollywood Hindi Songs.SELANGOR: The Association of Muslim Lawyers says a law suit against the Selangor Islamic Religious Council (MAIS) is a "misuse of judicial powers" as it challenges religious council decisions not in the public interest. Association president and lawyer Tuan Ibrahim Tan Tuan Ibrahim (pic) said he was not filing the suit as a person but as a lawyer for the community. "The law is that the law has to be followed and if the action (MAIS) is in the public interest and not in the interest of an individual, then it is in the public interest, he said at a press conference on Wednesday. "As a professional lawyer, I am simply following the law," he said, adding that he found it difficult to understand how MAIS can be considered an "indefensible" body because it is a state registered religious body. "I am a Muslim first, and I am entitled to act in a manner that is in the public interest. "The whole point of having a MAIS is that it can act in the public interest and not for its own interest," he said, adding that the action was the first step to making the state human rights commission independent from the government. "I am concerned that it seems to be abusing the royal prerogative," he said, adding that it had the authority to issue a directive to the religious council as it is a registered body. The decision was announced by the Shariah high council on September 18, and the MAIS asked for an explanation from the association. Ibrahim, who lives in Petaling Jaya, said the decision was based on the Federal Constitution and the Shariah law which is separate from state laws. "A Menteri Besar is not equal to an Islamic religious council. It is the same as a state advisory council. The Islamic courts can rule on their own free will but the state advisory council cannot," he said. Ibrahim said the decision constituted a "blatant misuse of judicial power". "It is a most unfortunate development that a body of a religious council does not seem to appreciate the autonomy of the courts and the constitution. This is a most unfortunate state
