The record supports this finding. 15 The record also supports the district court's finding that the breakaway and discord in the employer corporation arose before the agreement was created and that the agreement simply gave effect to what the employer corporation already knew: Mr. Muniz had agreed to relinquish the majority of his shares in his employer corporation. The record does not support Mr. Muniz's assertion that his agreement was not assented to by the employer corporation; the district court's finding that the board of directors never agreed to it is not clearly erroneous. 16 The district court found the agreement unenforceable against the corporation under Ky.Rev.Stat.Ann. Sec. 271B.5-103, which states in part: "No contract for the sale... of securities is valid unless... at least one (1) of the parties is an approved securities agent or underwriter...."
